The Office of the Australian Information Commissioner (OAIC) is responsible for promoting and upholding information access rights under the *Freedom of Information Act 1982* (FOI Act) and upholding the privacy rights of Australians under the *Privacy Act 1988*. The agency also administers the Notifiable Data Breaches regime. In total, the OAIC has regulatory responsibilities under 39 Commonwealth statutes including the My Health Record Act and Digital Health, Consumer Data Right, Digital ID, Social Media Minimum Age, Telecommunications and Credit Reporting. The effective administration of these regimes is essential to support public trust in Government and the safety of Australians.

Australians have told us that access to government information improves transparency and accountability, and is important. The proposed package of FOI Reforms is extensive, involving at least 31 different sets of amendments. These reforms will be enacted alongside an environment where individual requests for merits review of agency decisions under the FOI Act, complaints about interferences with personal privacy under the Privacy Act and notifiable data breach incidents are all increasing dramatically. The OAIC received more IC review requests, FOI complaints, privacy complaints, and notifiable data breach notifications in every month of 2025 (compared to 2024), with the exception of April; for example, in July 2025 the OAIC received 107% more IC review applications, 186% more FOI complaints, and 100% more privacy complaints compared to July 2024. The number of Notifiable Data Breaches has also continued to increase at least 15% period on period.

The OAIC is a small agency of approximately 160 FTE. It has improved case management efficiency in FOI IC reviews and individual privacy complaints in recent years, through a focus on ongoing case management process reforms, workforce restructuring and surge efforts. As a result, the agency is processing and finalising more cases in all jurisdictions, for example, the number of privacy complaints finalised in July 2024 was the highest result for the agency in a decade, and 722 more FOI IC reviews were finalised in 2024-25 than the year prior (952 more than 2022-23). Significant results have also been realised in reducing the number of aged matters on hand, for example, in 2024-25, the agency closed all outstanding 2018 privacy complaints, and all FOI IC reviews from 2020; there were 10 privacy complaints in total remaining on foot for 2019-2021, and 44 FOI IC reviews for 2021, at the close of the financial year. The OAIC also reduced the backlog of 2022 and 2023 privacy


